Grasshopper Group, LLC ("Grasshopper"), Citrix Systems, Inc., and LogMeIn, Inc. ("LogMeIn") (collectively the "Parties"), by undersigned counsel, hereby notify the Kentucky Public Service Commission ("Commission"), of the consummation of the transfer of control of Grasshopper to LogMeIn ("Transaction") on May 11, 2017, as part of a multi-step Reverse Morris Trust transaction, which was described in the Parties' September 26, 2016 notification.

Grasshopper was authorized to provide resold interexchange telecommunications services as utility 5179600 within the State of Kentucky in Docket No. TFS2012-01137. It is the Parties' understanding that formal Commission approval of the Transaction was not required. The Parties previously notified the Commission of their intent to enter into the Transaction on September 26, 2016.
