Dear Mr. Dorman:

On April 12, 2002, Network Plus, Inc. ("Network Plus") and Broadview NP Acquisition Corp. d/b/a Broadview Net Plus ("BNP", and together with Network Plus, "Parties"), by their counsel, filed a Notification regarding the transfer of assets, including customers, of Network Plus to BNP, and the discontinuance of service by Network Plus. BNP's request for authority to provide interexchange service to enable it to serve the former customers of Network Plus was granted by the Kentucky Public Service Commission (the "Commission") and BNP was issued #5163400 as its Company Identification number. This letter is to advise the Commission that the transaction that was the subject of the Notification is complete. BNP is now serving the former customers of Network Plus in Kentucky.


As described in the Notification, this transfer is transparent to customers as they are currently continuing to receive service pursuant to the same rates, terms and conditions of service. To that end, the Parties understand that BNP has provided the Commission with the necessary tariffs and the Parties hereby request that Network Plus' tariffs be cancelled. In addition, at this time, Network Plus is no longer providing service in Kentucky, and the Parties request that Network Plus' authority to provide interexchange service pursuant to its certificate granted on August 24, 1994, in Case No. 94-170 be surrendered.
