Re: WinStar Wireless, Inc.'s Notification of Intent to Provide Resold and Facilities-based Local Exchange Services in the Commonwealth of Kentucky

Dear Ms. Helton:

On behalf of WinStar Wireless, Inc. ("WinStar" or the "Company"), enclosed for filing is WinStar's proposed tariff for facilities-based and resold local exchange services. WinStar, through this letter and the enclosed tariff, notifies the Commission of its intent to provide resold and facilities-based local exchange services throughout the State of Kentucky. Consistent with the regulatory requirements set forth in the Commission's Order in Administrative Case No. 359, dated June 21, 1996, the tariff is to be effective thirty (30) days from the date of this filing.

WinStar currently operates as an interexchange service reseller and a competitive access provider in Kentucky pursuant to the Commission's authorization.¹ Information concerning the legal, technical, managerial and financial qualifications of WinStar was submitted with the various application(s) filed with the Commission with respect to WinStar's current operation in Kentucky, and is, therefore, already a matter of record with the Commission. WinStar respectfully requests that the Commission take official notice of this information and incorporate it by reference therein.

¹ WinStar Wireless, Inc. acquired MidCom Communications, Inc., a certificated long distance provider in Kentucky, in Case No. 92-138 (October 8, 1992). MidCom Communications, Inc.'s name was changed to WinStar Wireless, Inc. The Commission has been notified of the change in name in a letter dated March 4, 1998.


