RULES AND REGULATIONS

DISCONTINUANCE OF SERVICE BY UTILITY

The utility may refuse or discontinue service to an applicant or customer, after proper notice, for failure to comply with its rules and regulations or state and municipal rules and regulations, when a customer or applicant refuses or neglect to provide reasonable access to the premises, for fraudulent or illegal use of service, or for nonpayment of bills. If discontinuance is for non-payment of bills, the customer shall be given at least forty-eight (48) hours written notice, separate from the original bill, and cut-off shall be effected not less than twenty (20) days after the mailing date of the original bill unless, prior to discontinuance, a residential customer presents to the utility a written certificate, signed by a physician, registered nurse, or public health officer, that such discontinuance will aggravate an existing illness or infirmity on the affected premises, in which case discontinuance may not be effected until the affected resident can make other living arrangements or until not less than ten (10) days elapse from the date of the Utility's notifications. When a dangerous condition is found to exist on the customer's or applicant's premises, the service shall be cut off without notice or refused, provided that the utility notify the customer or applicant immediately of the reasons for discontinuance or refusal and the corrective action to be taken by the applicant or customer before service can be rendered. 1. Meters will be read monthly on or about the 20th of each month.
2. Bills will be dated and mailed on or about the first of each month. Said bills will state that they are to be paid within ten days. If not paid paid by the 10th of the following month, a ten percent penalty will be applied to the bill.
3. All meters will be located on DISTRICT mains and in the absence of special permission on the property to be served.
4. Complaints may be made to the operator, Gatewood Water Service (502) 695-2641, of the system and may be appealed to the District Commission.
